URGENT AGENDA POINTS

ITEM 1 : FEES STRUCTURE FOR OUTSTANDING SPORTSMEN

2. The fees structure after approval by the Executive Council was put up to the Govt. under the provisions of Section 11(5) of the University Act to approve as the Governing Body authorised to do so under Section 6(1) (xx) has not been constituted. The Sports Minister while approving the fees structure for all the courses instructed "consider higher fees exemption to the outstanding sportsmen in line with the other universities".
3. After checking from Punjab University, Punjabi University and Guru Nanak Dev University, it has been decided that the 'Outstanding Sportspersons' will be granted the following exemptions :-
- 1) **Complete Fee except : -**
 - a) Registration Fee of Rs. 1000/- for fresh admissions.
 - b) Caution Money (Refundable) of Rs. 2000/- per annum.
 - c) Identity Card and Magazine fee of Rs 100 each.
 - 2) **Complete Hostel charges for the top 10 'Outstanding Sportspersons 'only.**
 - 3) **Boarding Charges shall be paid by all students; however, the University May bear expenses on extra diet for the outstanding sportspersons, whenever necessary.**
4. The following will be considered as Outstanding Sportspersons:-
- 1) For Undergraduate Courses, the top three position holders at the National and State Level Competitions.
 - 2) For Post-Graduation courses, the top three position holders at the Inter-University Games/ National Level Competitions.
5. A duly Constituted Committee of the University will decide the sportspersons to be exempted hostel charges, provided extra diet and other related details within the ambit of the policy mentioned above. The policy will be reviewed from time to time.
6. *Decision: - The Committee ratified the agenda item.*

ITEM 2: POST MATRIC SCHOLARSHIP TO STUDENTS BELONGING TO SCHEDULED CASTES FOR STUDIES IN INDIA

7. The MBSPSU will follow the Scheme for Post Matric Scholarship to Students belonging to Scheduled Castes issued by the Govt. of India and Govt. of Punjab from time to time.
8. *Decision. The Committee Approved the Agenda Item.*
