1. The Vice-Chancellor (Chairperson) thanked the participants for making it convenient to attend the 3rd Executive Council (EC)meeting conducted via circulation through email from 03.09.2020 to 07.09.2020 due to the Covid-19 Lockdown restrictions.

URGENT AGENDA POINTS FOR EXECUTIVE COUNCIL

ITEM 1: FEES STRUCTURE FOR OUTSTANDING SPORTSMEN

- 2. The fees structure after approval by the Executive Council was put up to the Govt. under the provisions of Section 11(5) of the University Act to approve as the Governing Body authorised to do so under Section 6(1) (xx) has not been constituted. The Sports Minister, while approving the fees structure for all the courses instructed, "consider higher fees exemption to the outstanding sportsmen in line with the other universities".
- 3. After checking from Punjab University, Punjabi University, and Guru Nanak Dev University, it has been decided that the 'Outstanding Sportspersons' will be granted the following exemptions:-
 - 1) Complete Fee except:
 - a) Registration Fee of Rs. 1000/- for fresh admissions.
 - b) Caution Money (Refundable) of Rs. 2000/- per annum.
 - c) Identity Card and Magazine fee of Rs 100 each.
 - 2) Complete Hostel charges for the top 10 'Outstanding Sportspersons 'only.

- 3) All students shall pay boarding Charges; however, the University may bear expenses on the extra diet for the outstanding sportspersons, whenever necessary.
- 4. The following will be considered as Outstanding Sportspersons:-
 - 1) For Undergraduate Courses, the top three position holders at the National and State Level Competitions.
 - 2) For Post- Graduation courses, the top three position holders at the Inter-University Games/ National Level Competitions.
- 5. A duly Constituted Committee of the University will decide the sportspersons to be exempted from hostel charges, provided extra diet and other related details within the ambit of the policy mentioned above. The policy will be reviewed from time to time.
- 6. Decision. The Principal Secretary (Sports and Youth Services) has approved implementing the Fees exemptions for outstanding sportsmen for two years. A fresh proposal will be examined after two years.

ITEM 2: POST MATRIC SCHOLARSHIP TO STUDENTS BELONGING TO SCHEDULED CASTES FOR STUDIES IN INDIA

- 7. The MBSPSU will follow the Scheme for Post Matric Scholarship to Students belonging to Scheduled Castes issued by the Govt. of India and Govt. of Punjab from time to time.
- 8. Decision:- The EC members ratified the University proposal.

ITEM 3: DISTRIBUTION OF SEATS BASED ON RESERVATION POLICY

- 9. The Govt. has approved the reservation policy as recommended by the Executive Council in the meeting held on 21 July 2020. Based on the above policy, the distribution of seats for course strengths has been worked out as follows:-
 - 1) For Courses having Seats more than 30.
 - a) Schedule Caste/Scheduled Tribes SC/ST: 25%
 - b) Backward Class (OBC): 10%.
 - c) Border and Backward Area: 2% (1% each).
 - d) Sportspersons (3%) & Children/Grand Children of Freedom Fighters of Punjab, Terrorist Affected Persons and Sikh Riot Affected Persons (3%): 6%.
 - e) Children / Widows of Defence Personnel, Para-Military
 Forces Personnel (2%) & Disabled Persons (Blind/Deaf & Dumb/Other handicapped) (4%): 6%
 - 2) For Courses having Seats up to 30.
 - a) Schedule Caste/Scheduled Tribes SC/ST: 25%
 - b) Backward Class (OBC): 10%.
 - c) Border and Backward Area: 2% (1% each)
 - d) Sportspersons: 3%.

e) Children/Grand Children of Freedom Fighter of Punjab, Terrorist Affected Persons and Sikh Riot Affected Persons (3%); Disabled Persons (Blind/Deaf & Dumb/Other handicapped) (3%) & Children / Widows of Defence Personnel, Para-Military Forces Personnel (2%): 8%.

10. Decision:- The Principal Secretary (Sports and Youth Services) has approved to implement the policy for the current year. A fresh proposal will be put up for the next year.
