Subject: - Schedule and instructions regarding North Zone Inter University Hockey (Women) Championship 2024-25

I am pleased to inform you that The Maharaja Bhupinder Singh Punjab Sports University, Patiala has been given the responsibility to conduct the North Zone Inter University Hockey (Women) Championship for the session 2024-25 by the Association of Indian Universities, New Delhi. The venue of the competition has been fixed at "Khalsa College of Physical Education, Amritsar (Punjab)". On behalf of our university. Khalsa College of Physical Education, Amritsar is situated at about 13 kilometres from Airport, 4 kilometres from Amritsar Railway Station and about 6 kilometres from Amritsar Bus stand.

## INSTRUCTIONS

1. All the teams should report at the venue one day prior to the commencement of the Championship.
2. A meeting of the Coaches/Manager of teams will be held on a day 24<sup>th</sup> Nov, 2024 prior to the commencement of the Championship at 3:00 pm at the venue.
3. Players must bring with team their Identity Cards of the current session duly signed by the Registrar/Director Sports/Sports Officer of the concerned University
4. All the players should produce photocopy of the matriculation certificate, 10+2, B.A. and P.G. duly attested by the Director/Secretary (Sports) of the concerned University.
5. The Team Managers are required to submit Five Copies of the revised eligibility proforma (attached along with the email) duly typed and signed by the competent authority of the University as per AIU Rules. Incomplete proforma will not be entertained. No over-writing is permitted on the proforma unless attested by the competent authority of their University.
6. Team manager and coaches will be fully responsible for their players to maintain discipline at the venue and at the accommodation. The team Managers and Coaches must have authority letters issued in their name by their respective universities.
7. Officiating Charges/Match fee shall be charged as per latest rules of AIU.
8. The Manager of the team will have to deposit a sum of Rs. 2000/- per team as a refundable Security towards accommodation facilities.
9. Participating teams are requested to bring their own locks. All teams are responsible for their belongings.

**Important: Accommodation to teams will be provided one day before i.e. 24<sup>th</sup> Nov, 2024 morning onwards on payment basis.**

1. All Matches will be played as per AIU rules & regulations.

3. Teams should report 45 minutes before the schedule match.
4. The participating universities must produce the receipt of payment of 'registration fee' of Rs. 3000/- for the participation in the tournaments which is to be submitted online on the AIU portal.
5. Fixture may be revised if any entry is missed.
6. League Matches will be played from 28<sup>th</sup> to 29<sup>th</sup> Nov, 2024 onwards after the knock out matches.
7. Fixture of League matches will be drawn after the completion of knock out matches.
8. The timing of all the knock out matches shall be informed in the manages' meeting on 24<sup>th</sup> Nov, 2024 at 3 PM at the venue.
9. The organizing Committee reserves the right to change the venue, date, time and order of the matches etc. to be played as per situation, if and when necessary. The decision of the Organizing Committee shall be final & binding.
10. Objections (if any) against a team can be lodged as per AIU rules.


